4 The parties to this stipulation, Plaintiff STATE OF WASHINGTON (STATE) and  
5 Defendant EVERGREEN FREEDOM FOUNDATION d/b/a FREEDOM FOUNDATION  
6 (FREEDOM FOUNDATION), desiring to resolve all claims arising out of the State's Complaint  
7 and set forth in the parties' stipulated partial judgment that was entered on January 31, 2020,


10 1. Defendant FREEDOM FOUNDATION agrees to pay to the STATE the amount  
11 of \$80,000.00, inclusive of the State's reasonable costs of investigation and trial, including its  
12 reasonable attorneys' fees, for Defendant FREEDOM FOUNDATION's violations of RCW  
13 42.17A as alleged in the State's Complaint and as set forth in the parties' stipulated partial  
14 judgment that was entered on January 31, 2020.

15 2. Defendant FREEDOM FOUNDATION agrees to pay this \$80,000.00 amount by  
16 check made payable to the State of Washington within 30 days from the date of the entry of the  
17 Judgment.


1 **JUDGMENT**

2 The Court, having reviewed the records and files herein, and having found the settlement  
3 to be a just and proper resolution of this matter, and being otherwise fully advised in the  
4 premises, hereby ORDERS as follows:

5 1. The State of Washington is awarded judgment against Defendant FREEDOM  
6 FOUNDATION in the amount of \$80,000.00, inclusive of the State's reasonable costs of  
7 investigation and trial, including its reasonable attorneys' fees, for Defendant FREEDOM  
8 FOUNDATION's violations of RCW 42.17A as alleged in the State's Complaint and as set forth  
9 in the parties' stipulated partial judgment that was entered on January 31, 2020.

10 2. No interest shall accrue if Defendant FREEDOM FOUNDATION pays the State  
11 this \$80,000.00 amount by check made payable to the State of Washington within 30 days from  
12 the date of the entry of this Judgment.
