The parties to this stipulation, the Plaintiff, STATE OF WASHINGTON, and the Defendant, E-Juice Vapor, Inc., being desirous of resolving all claims arising out of this complaint, hereby enter into the following stipulation:

1. The Defendant will pay an assessed civil penalty in the amount of \$375,000 for its violations of RCW 70.345.090 and related violations of RCW 19.86.020.
2. The Defendant shall pay to the State the civil penalty on or before August 1, 2021.

2 **III. JUDGMENT**

3 THIS MATTER having come before the undersigned judge of the above-entitled Court;  
4 and the Plaintiff, State of Washington, acting by and through Robert W. Ferguson, Attorney  
5 General, and Brendan Selby, Assistant Attorney General, and the Defendant, E-Juice Vapor, Inc.,  
6 acting by and through Michael Hurey, having apprised the Court of their agreement to the entry of  
7 this judgment for the purpose of settling and compromising this action brought under RCW  
8 70.345.090 and RCW 19.86.020. The Court, after a review of the files and records herein, finding  
9 that the sum of Three Hundred Seventy Five Thousand and No/100 Dollars (\$375,000.00) is a  
10 proper and just settlement to be paid by the Defendant, E-Juice Vapor, Inc., to the Plaintiff; and the  
11 Court being fully advised, now, therefore,

12 IT IS HEREBY ORDERED that the Plaintiff, State of Washington, shall have judgment  
13 against the Defendant E-Juice Vapor, Inc. for the total sum of Three Hundred Seventy Five  
14 Thousand and No/100 Dollars (\$375,000.00), payable to the State of Washington as an assessed  
15 civil penalty for Defendant's violations of RCW 70.345.090 and RCW 19.86.020, as alleged in the  
16 Complaint filed in this case.

17 IT IS FURTHER ORDERED that the assessed civil penalty described in the preceding  
18 paragraph shall be paid on or before August 1, 2021.

19 IT IS FURTHER ORDERED that the amount of the assessed penalty not paid to the State  
20 of Washington by August 1, 2021, shall bear interest at the rate of 12% per year from  
21 August 1, 2021, until paid.
