## Overview

The M.E.D.A.L. (MILITARY ENGAGEMENT AND DIRECTED ADVOCACY BY LAWYERS) Program connects volunteer attorneys to eligible military and veteran families facing select civil legal issues.

## Military Service Members & Veterans

### Am I eligible?

You are eligible to request assistance through the M.E.D.A.L. program if:

- You are currently serving or formerly served in any branch of the military (active duty, Reserves, or National Guard);
- You are domiciled or stationed in Washington State;
- Your income is at or below 400% of the Federal Poverty Guidelines; and
- You aren't otherwise represented by or able to pay for a private attorney.

### What types of legal issues can the M.E.D.A.L. program help with?

Subject to volunteer availability, the M.E.D.A.L. Program offers help connecting to civil legal assistance with:

- Consumer Law;
- Employment Law;
- Estate Planning;
- Family Law;
- Landlord/Tenant;
- Servicemembers Civil Relief Act;
- Small Claims Assistance; and
- Some small business legal issues related to COVID-19

The program cannot help with criminal legal matters.

### How do I request assistance?

To make sure help goes to those who need it the most, individuals requesting assistance from the M.E.D.A.L. Program are encouraged to explore options for legal assistance that may be available from other channels.

For example, current military service members should first visit a local military legal assistance office and consult with a military assistance attorney.

### Who will be assisting me?

Under state law, the Attorney General's Office cannot provide direct legal advice or representation, but instead recruits and trains volunteer attorneys, and connects them to military service members in need of legal assistance.

M.E.D.A.L. Program volunteer attorneys are licensed members of the Washington State Bar Association authorized to practice law in Washington State.
