I, Robert W. Ferguson, Attorney General of Washington, in the name and by the authority of the State of Washington, pursuant to RCW 43.10.232 and at the request of Jason Cummings, Snohomish County Prosecuting Attorney, hereby allege BLAYNE M. PEREZ did commit the following crimes:

Count 1: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

That the defendant, on or about the 25th day of September, 2022, did intentionally and unlawfully inflict substantial pain on, or cause physical injury to, an animal, to wit: Hades, a domestic cat; proscribed by RCW 16.52.205(1), a felony. (Max penalty: 5 years confinement and \$10,000 fine)

Count 2: FIRST DEGREE MALICIOUS MISCHIEF, committed as follows:

That the defendant, on or about the 25th day of September, 2022, did knowingly and maliciously cause physical damage to the property of another, to wit: Hades, a domestic cat, in an amount exceeding \$5,000; proscribed by RCW 9A.48.070, a felony. (Max penalty: 10 years confinement and \$20,000 fine)

Count 3: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

That the defendant, on one or more dates between on or about the 5th day of January, 2022 and on or about the 17th day of February, 2022, did intentionally and unlawfully inflict substantial pain on, cause physical injury to, or kill an animal, to wit: crow, identified as Lab #6 while

1 manifesting an extreme indifference to life; proscribed by RCW 16.52.205(1), a felony. (Max
2 penalty: 5 years confinement and \$10,000 fine)

3 Count 4: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

4 That the defendant, on one or more dates between on or about the 5th day of January, 2022 and
5 on or about the 17th day of February, 2022, did intentionally and unlawfully inflict substantial
6 pain on, cause physical injury to, or kill an animal, to wit: crow, identified as Lab #7 while
7 manifesting an extreme indifference to life; proscribed by RCW 16.52.205(1), a felony. (Max
8 penalty: 5 years confinement and \$10,000 fine)

9 Count 5: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

10 That the defendant, on one or more dates between on or about the 5th day of January, 2022 and
11 on or about the 17th day of February, 2022, did intentionally and unlawfully inflict substantial
12 pain on, cause physical injury to, or kill an animal, to wit: crow, identified as Lab #8 while
13 manifesting an extreme indifference to life; proscribed by RCW 16.52.205(1), a felony. (Max
14 penalty: 5 years confinement and \$10,000 fine)

15 Count 6: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

16 That the defendant, on one or more dates between on or about the 5th day of January, 2022 and
17 on or about the 17th day of February, 2022, did intentionally and unlawfully inflict substantial
18 pain on, cause physical injury to, or kill an animal, to wit: junco, identified as Lab #9 while
19 manifesting an extreme indifference to life; proscribed by RCW 16.52.205(1), a felony. (Max
20 penalty: 5 years confinement and \$10,000 fine)

21 Count 7: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

22 That the defendant, on one or more dates between on or about the 5th day of January, 2022 and
23 on or about the 17th day of February, 2022, did intentionally and unlawfully inflict substantial
24 pain on, cause physical injury to, or kill an animal, to wit: chickadee, identified as Lab #12
25 while manifesting an extreme indifference to life; proscribed by RCW 16.52.205(1), a felony.
26 (Max penalty: 5 years confinement and \$10,000 fine)

Count 8: FIRST DEGREE ANIMAL CRUELTY, committed as follows:

That the defendant, on one or more dates between on or about the 5th day of January, 2022 and
on or about the 17th day of February, 2022, did intentionally and unlawfully inflict substantial
pain on, cause physical injury to, or kill an animal, to wit: squirrel, identified as Lab #5 while
manifesting an extreme indifference to life; proscribed by RCW 16.52.205(1), a felony. (Max
penalty: 5 years confinement and \$10,000 fine)


