By providing this notice, PCLI does not waive any rights or defenses regarding the applicability of Washington law, the applicability of the Washington data event notification statute, or personal jurisdiction.

Nature of the Data Event

On November 13, 2023, PCLI identified suspicious activity within their network environment. PCLI immediately took steps to secure their network and launched an investigation to determine the nature and scope of the activity. Through its investigation, PCLI determined that, between November 13, 2023, and November 14, 2023, an unauthorized actor had access to certain systems that contained files with personal and protected health information. As such, PCLI conducted a detailed review of the files at risk to determine the type of information present and to whom it related for purposes of providing notice.

The information that could have been subject to unauthorized access includes name, and Social Security Number, date of birth, digital signatures, employee ID number, medical history, treatment information/diagnosis, prescription information, provider name, MRN/patient ID, PCLI number, encounter number, health insurance information, treatment cost and patient status.

Notice to Washington Residents

On or about March 1, 2024, PCLI provided written notice of this incident to six thousand five hundred eighty-seven (6,587) Washington residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, PCLI moved quickly to investigate and respond to the incident, assess the security of PCLI systems, and identify potentially affected individuals. Further, PCLI notified federal law enforcement regarding the event. PCLI is also working to implement additional safeguards and training to its employees. PCLI is providing access to credit monitoring services for twelve (12) months, through Epiq, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, PCLI is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. PCLI is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

PCLI is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion. PCLI is also notifying the U.S. Department of Health and Human Services and prominent media.

We are notifying you because the investigation recently determined information related to you was contained within the files.

What Information Was Involved? We determined that the following information related to you was in the files that were subject to unauthorized access: <<DataElements>>, and your name.

What We Are Doing? The confidentiality, privacy, and security of information within our care is Pacific Cataracts' highest priority. Upon learning of the incident, we took immediate steps to secure our network environment and investigate the activity. We launched an investigation to understand the nature and scope of the incident. As part of our ongoing commitment to the security of information, we are reviewing our policies and procedures related to data privacy to reduce the likelihood of a similar future event. We are also notifying applicable regulatory authorities, as required by law. As an added precaution, we are also offering <<CM Duration>> months of complimentary access to credit monitoring services through Equifax. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
