Based on ongoing efforts to identify contact information for those individuals who may be affected by this event, on October 30, 2024, David's Bridal will be providing notice to an additional three (3) Washington residents. Nature of the Data Event

On or about January 21, 2024, David's Bridal identified unusual activity on certain network systems and promptly began an investigation to determine the full nature and scope of the event. Through the investigation, it was determined that certain information may have been copied from the system without authorization on or around January 20, 2024 as part of a cyber incident. David's Bridal then began a comprehensive review of the relevant files to confirm what information was present, to whom the information related, and contact information for those individuals. Based on these efforts, on or around August 15, 2024, David's Bridal determined that certain Washington residents may be affected. The potentially impacted information related to Washington includes name, Social Security number, health insurance information, medical information and date of birth. It was determined that this incident did *not* include consumer payment card information.

Notice to Washington Residents

On or about September 13, 2024, David's Bridal began providing written notice of this incident to individuals for whom it has contact information, which includes nine hundred eight (908) Washington residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

In response to this incident, David's Bridal promptly took steps to further secure and restore its systems. It also undertook a comprehensive forensic investigation to confirm the nature and scope of the event, and the data potentially affected. Based on these efforts, it completed a detailed data review to identify what information was present in the relevant files and determine to whom that information related, as well as confirm contact information for those individuals. Further, David's Bridal notified federal law enforcement regarding the event.

David's Bridal is now providing potentially impacted individuals notice of this incident, which includes guidance on how to better protect against identity theft and fraud. As demonstrated in the attached Exhibit A, this notification includes information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.
