RE: NOTICE OF DATA BREACH

Dear <<Full Name >>:

Western Alliance Bank ("Western Alliance") values and respects the privacy of your information, which is why we are writing to advise you of an incident that involved some of your personal information. We have no evidence to believe that your personal information has been misused for the purpose of committing fraud or identity theft. Nonetheless, we are writing to advise you about the isolated incident and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

What Happened? A third-party vendor's secure file transfer software used by Western Alliance and numerous other organizations had an unknown vulnerability. In October 2024, an unauthorized actor began exploiting this unknown vulnerability in the third-party software that allowed the unauthorized actor to gain access to a limited portion of Western Alliance's systems and to obtain copies of files from those systems. Western Alliance learned that an unauthorized actor had potentially accessed some of Western Alliance's data on January 27, 2025. Our investigation determined that the unauthorized actor acquired certain files from the systems from October 12, 2024, to October 24, 2024. Western Alliance has notified law enforcement of this incident.

What Information Was Involved? We reviewed the contents of the files acquired by the third party to determine if they contained any personal information. On June 3, 2025, we determined that the files contained some of your personal information, including your << Data Elements>>, and confirmed your mailing address to notify you of the incident.

What We Are Doing. In addition to the actions described above, Western Alliance has taken and will continue to take steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Although we are not aware of any instances of fraud or identity theft involving your information, we are offering a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary membership, please see the additional information provided in this letter.

What You Can Do. While we have no evidence that your personal information has been misused as a result of this incident, we encourage you to take advantage of the complimentary credit monitoring included in this letter. You should also promptly report any fraudulent activity or any suspected incidents of identity theft to proper law enforcement authorities, including the police and your state's attorney general, as well as the Federal Trade Commission ("FTC").

Fraud Alerts: By law, you have the right to place a fraud alert on your credit report if you believe you have been, or are about to become, a victim of fraud or related crime. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Credit and Security Freezes: By law, you have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
