

# **EXHIBIT 1**

By providing this notice, Healthcare Services Group, Inc. (“HSGI”) does not waive any rights or defenses regarding the applicability of Washington law, the applicability of the Washington data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On October 7, 2024, HSGI learned of potential unauthorized access to certain HSGI computer systems. Upon learning of the activity, HSGI quickly took steps to secure its computer systems and began an investigation to determine the nature and scope of the activity. The investigation determined that an unauthorized actor may have accessed and copied certain files on HSGI’s computer systems between September 27, 2024, and October 3, 2024. As a result, we undertook an extensive review of the involved files to determine whether they contained sensitive information and to whom the information relates. This review recently concluded, and HSGI determined that certain personal information was present in the files.

The personal information that could have been subject to unauthorized access includes name, Social Security number, date of birth, driver’s license number, state identification number, financial account information, health insurance information, medical information, full access credentials, biometric identifiers, government issued identification number and passport number.

### **Notice to Washington Residents**

On or about August 25, 2025, HSGI provided written notice of this incident to approximately seven thousand seven hundred forty-five (7,745) Washington residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, HSGI moved quickly to investigate and respond to the incident, assess the security of HSGI systems, and identify potentially affected individuals. Further, HSGI notified federal law enforcement regarding the event. HSGI is also working to implement additional safeguards and training to its employees. HSGI is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, HSGI is providing impacted individuals with guidance on how to better protect against identity theft and fraud. HSGI is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

HSGI is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

Healthcare Services Group, Inc. ("HSGI") is writing to inform you of an incident that may impact the privacy of some of your information. Although we are not aware of any identity theft or fraud as a result of this incident, we are providing you with information about the incident, our response, and steps you can take, should you feel it appropriate to do so.

**What Happened?** On October 7, 2024, we learned of potential unauthorized access to certain HSGI computer systems. Upon learning of the activity, we quickly took steps to secure our computer systems and began an investigation to determine the nature and scope of the activity. The investigation determined that an unauthorized actor may have accessed and copied certain files on our computer systems between September 27, 2024, and October 3, 2024. As a result, we undertook an extensive review of the involved files to determine whether they contained sensitive information and to whom the information relates. This review recently concluded, and you are receiving this notice because we determined that some of your information was present in the files.

**What Information Was Involved?** Based on the investigation, the potentially impacted data varied from individual to individual, but we determined your name, <<Data Elements>> may be affected.

**What We Are Doing.** HSGI treats the responsibility to safeguard information in its possession as a priority. Upon learning of this incident, we promptly took steps to secure our systems, began a comprehensive investigation, and worked to provide affected plans individuals with notice. As part of our commitment to the privacy and security of information in our care, we continue to review and enhance existing policies and procedures relating to data protection and security. We have implemented additional security measures to mitigate risk associated with this event and to help prevent similar future incidents. We have also notified relevant state and federal regulators as applicable. Additionally, HSGI notified federal law enforcement.

Out of an abundance of caution, we are also offering you complimentary access to <<12/24>> months of credit monitoring and identity restoration services through Experian. While we are covering the cost of these services, due to privacy restrictions, you will need to complete the activation process yourself. Enrollment instructions are included in this letter below.

**What You Can Do.** Although there is no evidence of any actual or attempted identity theft of or fraud related to your information, as a general best practice, we encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports and explanation of benefits for suspicious activity and to detect errors. You can also find out more about how to safeguard your information in the enclosed *Steps You Can Take to Protect Your Personal Information*.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
