

On November 11, 2025, Harnish Group Inc. became aware of an incident that resulted in the unauthorized disclosure of Personal Identifiable Information. You are receiving this notification because you are one of the current or previous employees whose Personal Identifiable Information has been disclosed.

We hired experts to conduct an in-depth forensic investigation. The consultants identified the type of cyber attack that occurred, the account used to gain access to our network, and how the attack was conducted once the Bad Actor had access to our network. The consultants also confirmed that we have completed all changes to our network to prevent this attack from reoccurring.

On December 9, 2025, the responsible party publicly posted files that were obtained from our servers. By reviewing each of those documents we identified that your First and Last Name and Social Security Number were contained in the released data.

### **What You Can Do**

**We have partnered with Norton LifeLock to provide you a 2-year subscription for identity theft monitoring services.** Enclosed please find details on enrolling in this program. *Given the nature of the Personal Identifiable Information we have noted, we strongly encourage you to enroll in this program.* If you have received Norton LifeLock enrollment information from Human Resources, there is no further enrollment information needed.

If you choose not to enroll in Norton LifeLock we strongly urge you **to place a fraud alert with one of the three major credit agencies directly at:**

- **Upon receipt of your credit report**, we recommend that you review it carefully for any suspicious activity.
