

# **EXHIBIT 1**

This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, The UA Sprinkler Fitters Local 669 Joint Apprenticeship and Training Committee (“JATC”) does not waive any rights or defenses regarding the applicability of Washington law, the applicability of the Washington data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On or about May 23, 2024, the JATC became aware of suspicious activity related to certain computer systems. Additionally, the JATC launched an investigation with the assistance of a third-party forensic specialists to secure its network and to determine the nature and scope of the activity.

Through the investigation, it was determined that there was unauthorized access to the network between May 17, 2024, and May 23, 2024.

As part of the investigation, the JATC undertook an extensive forensic review of the potentially impacted files to determine whether any sensitive information was present. It was through this process, which concluded on January 28, 2026, that it was determined that information pertaining to certain individuals may have been included in the involved files.

The information that could have been subject to unauthorized access includes name, Social Security number, driver’s license number or state ID number, and medical information.

### **Notice to Washington Residents**

On or about February 6, 2026, the JATC provided written notice of this incident to five hundred eighteen (518) Washington residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, the JATC moved quickly to investigate and respond to the incident, assess the security of the JATC systems, and identify potentially affected individuals. Further, the JATC notified federal law enforcement regarding the event. The JATC is also working to implement additional safeguards and training to its employees. The JATC is providing access to credit monitoring services for one (1) year, through TransUnion, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, the JATC is providing impacted individuals with guidance on how to better protect against identity theft and fraud. The JATC is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

The JATC is providing written notice of this incident to relevant state and federal regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

## NOTICE OF SECURITY INCIDENT

Dear [REDACTED]:

The UA Sprinkler Fitters Local 669 Joint Apprenticeship and Training Committee (“JATC”) values our relationship with applicants, apprentices, and contracting partners, and maintaining your trust and confidence is important to us. Our organization was the target of a cybersecurity attack by an international criminal group that impacted our computer network. We are writing to inform you about what happened, what information was involved, what we have done to address the situation and what you can do to help protect you against possible misuse of information.

### What Happened?

On or about May 23, 2024, we became aware of suspicious activity related to certain JATC computer systems. Upon learning of the activity, with the assistance of a third-party forensic specialists, we launched a comprehensive investigation to secure our network and to determine the nature, scope, and impact of the activity.

Through the investigation, it was determined that certain files from our computer systems were copied by an unauthorized actor between May 17, 2024 and May 23, 2024.

As part of our investigation, we undertook an extensive forensic review of the potentially impacted files to determine whether any sensitive information was present. It was through this process, which concluded on January 28, 2026, that we determined that information pertaining to you may have been included in the impacted files.

### What Information Was Involved?

The information involved may include some combination of the following data types for you: <<*data elements*>>.

### What We Are Doing.

The JATC takes the security of your information seriously. Upon learning of this incident, we quickly took steps to secure our network and maintain operations in a safe and secure fashion to continue serving the community. As part of our ongoing commitment to the privacy of personal information in our care, we continue to review our existing policies and procedures and implement additional administrative and technical safeguards to further secure the information on our systems. We remain committed to fully complying with all state and federal requirements and maintaining timely and transparent communication with our members and applicants.

## Steps You Can Take To Protect Personal Information

### **Enroll in Monitoring Services**

In response to the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twelve (12) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in the event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

### **How do I enroll for the free services?**

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services:

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

### **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
