To Whom It May Concern:

We serve as counsel for Unibail-Rodamco-Westfield (“URW”) located at 2049 Century Park East, 42nd Floor, Los Angeles, CA 90067, and write to inform you of a cybersecurity incident.


On February 18, 2026, URW discovered a cybersecurity incident that occurred between February 12, 2026 and February 18, 2026. The incident affected one of its IT systems, which resulted in unauthorized access to files containing limited loyalty-program customer information and newsletter-subscriber data related to one of its locations, Westfield Southcenter. Upon discovery, URW immediately took action to contain and investigate the incident, confirming that it did not impact the company’s broader IT or operational ecosystem. URW began a comprehensive review of the impacted files to determine the type of information contained therein and to whom that information related. On March 12, 2026, this comprehensive review process was completed.

At that time, URW determined that information related to 5,723 Washington residents may have been subject to unauthorized access. The information believed to be risk may include a first and last name in combination with a date of birth.

On March 18, 2026, URW sent written notice of this incident via email to all potentially impacted Washington residents pursuant to Washington state law. A copy of the written notice distributed via email has been provided with this submission. Out of an abundance of caution, URW also provided a notice on its Westfield Southcenter website as well as to statewide media in Washington.

Subject: Information Regarding Personal Data

Dear Westfield Southcenter Customer,

We are writing to inform you of a recent data security incident that may have involved some of your information associated with our loyalty program or newsletter subscription. We assure you that no financial information, including bank account or credit card numbers, or passwords were affected.

On February 18, 2026, Unibail-Rodamco-Westfield (URW) identified unauthorized access to one of its IT systems. Immediate steps were taken to secure the environment, and a thorough investigation was launched. Through the investigation, URW determined that a database containing limited loyalty-program customer information and newsletter-subscriber data may have been subject to unauthorized access between February 12 and February 18, 2026.

On March 12, 2026, URW completed a comprehensive review of the impacted database to determine which customers may have been affected. The information contained in this database potentially subject to unauthorized access may include your first and last name, and if provided, your date of birth.

While we have no evidence of attempted or actual misuse of any information, we are providing you with this notification out of an abundance of caution and we want to ensure you have resources should you wish to take additional precautions.
