**Re: Legal Notice of Security Incident**

Dear Sir or Madam:

I am writing on behalf of my client, US Tiger Securities Inc. ("US Tiger"), a fintech brokerage firm affiliated with TradeUP Securities, Inc. ("TradeUP"), to inform you of a cybersecurity incident.

On July 10, 2025, US Tiger discovered that they were the target of a cybersecurity incident and that files were encrypted in their virtual back-office environment that supports the shared back office functions of both US Tiger and TradeUP. In response, US Tiger immediately launched an investigation, engaged leading third-party cybersecurity experts, and notified law enforcement.

The investigation determined that some files were copied by an unauthorized third party from US Tiger's virtual environment between July 8, 2025, and July 9, 2025. Notably, the investigation indicated that no intrusion occurred within the TradeUP production environment, which is segmented, and customer facing trading operations were not impacted. A robust review of the data was conducted to identify individuals whose information may have been involved and worked to obtain addresses and notify individuals as quickly as possible after completing the review on April 17, 2026.

Today, May 15, US Tiger will begin mailing notification letters to 885 Washington residents. The information involved includes name, social security number, driver's license number, date of birth, military ID number, and passport number. US Tiger is offering 24 months of complimentary credit monitoring and fraud protection services. US Tiger is also providing a toll-free telephone number for individuals to call with any questions regarding the incident. A copy of the notification letter is attached.

To help prevent a similar incident from occurring in the future, US Tiger took numerous measures to enhance its security and continues to evaluate technical and organizational measures to enhance the security of its systems and data.

**Free Credit Report.** We remind you to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. If you identify any unauthorized charges on your financial account statements, you should immediately report any such charges to your financial institution. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. To order your annual free credit report, please visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call toll free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available from the U.S. Federal Trade Commission's ("FTC") website at [www.consumer.ftc.gov](http://www.consumer.ftc.gov)) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281.

**For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents:** You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

**Security Freeze.** Security freezes, also known as credit freezes, restrict access to your credit file, making it harder for identity thieves to open new accounts in your name. You can freeze and unfreeze your credit file for free. You also can get a free freeze for your children who are under 16. And if you are someone's guardian, conservator or have a valid power of attorney, you can get a free freeze for that person, too.

How will these freezes work? Contact all three of the nationwide credit reporting agencies –Equifax, Experian, and TransUnion. If you request a freeze online or by phone, the agency must place the freeze within one business day. If you request a lift of the freeze, the agency must lift it within one hour. If you make your request by mail, the agency must place or lift the freeze within three business days after it gets your request. You also can lift the freeze temporarily without a fee.

The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue.

**For New Mexico Residents:** You may obtain a security freeze on your credit report to protect your privacy and ensure that credit is not granted in your name without your knowledge. You may submit a declaration of removal to remove information placed in your credit report as a result of being a victim of identity theft. You have a right to place a security freeze on your credit report or submit a declaration of removal pursuant to the Fair Credit Reporting and Identity Security Act. **Fraud Alerts.** A fraud alert tells businesses that check your credit that they should check with you before opening a new account. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

**For Oregon Residents:** You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.

**For Rhode Island Residents:** You have the right to file or obtain a police report regarding this incident. 56 Rhode Island residents were impacted by this incident.
