Oracle's eBusiness Suite Application ("Oracle EBS") had a zero-day vulnerability that allowed unauthorized parties to exploit hundreds of Oracle customers EBS instances and access / exfiltrate data, including Bimbo Bakeries USA's ("BBU").

BBU completed its investigation of an incident that involved a zero-day vulnerability in Oracle EBS, which BBU uses to maintain business information. BBU first learned of the zero-day vulnerability on October 6, 2025 and immediately applied software patches provided by Oracle, and launched an investigation. At that time, it was not known what, if any, impact the vulnerability had on BBU's instance of Oracle EBS.

BBU's investigation later determined that the vulnerability in the Oracle EBS allowed unauthorized parties to access and acquire files stored in the application.

As part of its investigation, BBU worked to identify the files that were subject to unauthorized access / acquisition as a result of the vulnerability in Oracle EBS. BBU then undertook a review of those files to determine their contents.

On August 19, 2026, BBU determined files involved in the incident contained the names and Social Security numbers of certain current and former employees, their dependents and beneficiaries, and other individuals affiliated with BBU. For some current and former employees, bank account and routing numbers were also involved in this incident. On August 28, 2026, BBU confirmed that this incident involved information pertaining to 786 Washington residents.

Beginning on August 31, 2026, notification letters were mailed to individuals whose information was involved in the incident via United States Postal Service First-Class mail, in accordance with Wash. Rev. Code § 19.255.010, including 786 Washington residents. A copy of the notification letter is enclosed. Complimentary credit monitoring and identity protection services are being offered to individuals whose Social Security numbers were involved in the incident. A dedicated, toll-free incident response line has been established to answer questions that individuals may have about the incident.

To help prevent something like this from happening in the future, BBU is working to ensure that Oracle and other third-party providers deliver secure, compliant software and services, including the timely identification of vulnerabilities and execution of remediation plans.

Bimbo Bakeries USA is writing to notify you of a data security incident that involved our third-party vendor, Oracle. This notice explains the incident, measures we have taken, and steps you can take in response.

What Happened: We recently completed our investigation of an incident that involved a zero-day vulnerability in Oracle's E-Business Suite application. Upon learning of the zero-day vulnerability, we immediately applied patches provided by Oracle to address the vulnerability and launched an investigation. The investigation determined on December 6, 2025 that the zero-day vulnerability allowed unauthorized parties to acquire files stored in the Oracle's E-Business Suite application. As part of the investigation, we launched a comprehensive review to determine the contents of the files involved in the incident.

What Information was Involved: Through our review, on August 19, 2026, we identified a file involved in the incident that contains your name, and Social Security number.

What we are Doing: We deeply regret any inconvenience or concern this may cause you. To help prevent something like this from happening in the future, we are re-evaluating our vendor relationships.

What You Can Do: You are eligible to enroll in **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout, a TransUnion company specializing in fraud assistance and remediation services.

ENROLLMENT INSTRUCTIONS

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED] In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. To order your annual free credit report, please visit www.annualcreditreport.com or call toll free at 1-877-322-8228. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report. For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit. *How do I place a freeze on my credit reports?* There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze. *How do I lift a freeze?* A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request. If you opt for a temporary lift because you

are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

Rhode Island Residents: This incident involves 51 individuals in Rhode Island. Under Rhode Island law, you have the right to file and obtain a copy of a police report. West Virginia Residents: You have the right to ask that nationwide consumer reporting agencies place "fraud alerts" in your file to let potential creditors and others know that you may be a victim of identity theft, as described above. You also have a right to place a security freeze on your credit report, as described above.

A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You have a right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
