Re: Notice of Data Security Event

Dear Sir or Madam:

We represent the Amateur Athletic Union ("AAU"), located at 1910 Hotel Plaza Blvd., Lake Buena Vista, Florida 32830. We are writing to notify your office of an incident that may affect the security of payment card information relating to twelve thousand two hundred (12,200) Washington residents. The investigation into this matter is ongoing, and this notice may be supplemented if new significant facts are learned subsequent to its submission. By providing this notice, AAU does not waive any rights or defenses regarding the applicability of Washington law, the applicability of the Washington data event notification statute, or personal jurisdiction.

Nature of the Data Event

AAU, working with third party forensic investigators, identified signs of malicious code on the checkout page of its website, play.aausports.org, on August 2, 2019. The investigation determined that this code was capable of capturing certain information entered into the checkout page of AAU's website between October 1, 2018 and July 2, 2019. Upon making the determination of when the code was present on the website, AAU reviewed its transaction records to determine the identities of its members whose payment card information may be impacted. AAU recently confirmed the identities of the individuals whose payment card information may have been impacted and completed efforts to locate the address information for these individuals. The code at issue was removed from the site and members can safely use their payment card on AAU's website.

The information that could have been subject to unauthorized access includes cardholder name, address, credit card number, expiration date, and CVV.

Notice to Washington Residents

On or about September 13, 2019, AAU began providing written notice of this incident to affected individuals, which includes twelve thousand two hundred (12,200) Washington residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, AAU moved quickly to investigate and respond to the incident, assess the security of AAU systems, and notify potentially affected individuals. AAU is also working to implement additional safeguards.

Additionally, AAU is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. AAU is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. AAU is also providing written notice of this incident to other state regulators, as necessary.

The Amateur Athletic Union (AAU) is writing to inform you about a recent event that may have impacted the payment information for some website visitors and to assure you that we've taken additional steps to safeguard against future incidents. The AAU takes this incident and the security of your information very seriously.

The AAU has worked tirelessly during its 131 years of service to earn the public's trust as a champion of amateur sports across America, and we're committed to taking whatever steps necessary to maintain your ongoing support for that mission.

As a first step, we wanted to explain what happened and how we responded. We also want to tell you how to better protect yourself against potential fraud, if you think it's needed.

What Happened? On August 2, 2019, AAU, with the assistance of third-party forensic investigators, identified signs of malicious code on our site, play.aausports.org and determined that the code could capture information entered onto the site's checkout page from October 1, 2018 to July 2, 2019.

What Information Is Involved? The information potentially captured by the code includes the cardholder's name, address, and payment card information -- including number, expiration date, and CVV.

What We Are Doing. After determining exactly when the code was on the site, the AAU reviewed transaction records to promptly identify the names and addresses of everyone whose payment card data might have been compromised. We have completed that effort, and the code has been removed, which allows site visitors to again safely use their payment card on the checkout page.

With support from a team of forensics experts, we have conducted a thorough website review, in addition to implementing enhanced security measures to reduce the risk of a similar incident. The AAU has also notified the required state regulators and consumer reporting agencies about this incident. We want to again express our hope that these steps will help maintain your trust in the AAU as we move forward.

What You Can Do. You can learn more about how to protect against potential fraud in the enclosed "Steps You Can Take to Prevent Fraud and Identity Theft." We encourage you to remain vigilant against incidents of fraud by reviewing your account statements regularly and keeping a close eye on your credit card activity. If you see any suspicious activity, please report it to the bank that issued your credit card.

STEPS YOU CAN TAKE TO PREVENT FRAUD AND IDENTITY THEFT

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity. Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

You have the right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a security freeze on your credit report. In order to request a security freeze, you will need to provide the following information:

- 1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, military identification, etc.);
- 7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

As an alternative to a security freeze, you have the right to place an initial or extended "fraud alert" on your file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General.

Instances of known or suspected identity theft should also be reported to law enforcement and your state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit "prescreened" offers of credit and insurance you get based on information in your credit report; and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
