

Washington State Joint Legislative Task Force on Jail Standards

MEETING MINUTES

December 14, 2022 3:00 – 5:00 p.m.

1. Welcome

- Co-chair Devon Schrum welcomed Task Force members to the fifth meeting of the Joint Legislative Task Force on Jail Standards.
- Devon Schrum reviewed and made note of changes to the agenda that had been previously sent out. The task force adopted the new agenda for the December 14 meeting.
- Devon Schrum reviewed the previous meeting's minutes. The task force approved the November meeting minutes.
- Establishment of quorum. See list below.

2 Yakima County Jail, Behavioral Health Services

- Samantha Martinez, LICSW from Yakima County Behavioral Health Services presented on the following:
 - o Behavioral health services provided at the Yakima County Jail, including frequency and how individuals access care;
 - o Program improvements being made at the jail; and
 - O Challenges and barriers to providing behavioral health services in correctional settings. See slides on page 4.
- Samantha noted that Yakima County Behavioral Health Services provides a
 wide range of services to incarcerated individuals, which begins during the
 booking process. The screening tool was developed internally. There are forty
 hours of provider time per week and daily checks for symptomatic clients.
 Incarcerated individuals are able to access care by making a request or through
 referrals from jail staff, community mental health providers, family and friends
 of the incarcerated individual, and designated crisis responders.
- Samantha highlighted the following program improvements: creating an expanded 8-week program for those with mental illness, providing incentives for individuals in programming, increasing training for behavioral health staff, and providing cross-training between behavioral health and custody staff.
- Samantha concluded that despite these improvements, there are still many barriers and challenges to providing comprehensive and high-quality behavioral health services in correctional facilities, including
 - increased delays in people receiving competency restoration services (averaging about 3-5 months),

- o the physical environment is not conducive for those with neurocognitive disorders and developmental delays,
- o limited funding, and
- o difficulties coordinating and continuing care in the community.

3. Spokane County Tour Debrief

- Co-chair Devon Schrum facilitated a discussion among task force members, staff from the Washington Association of Sheriffs and Police Chiefs, and custody staff from Spokane County Corrections.
- Task force members who toured the downtown Spokane County Jail offered their reactions to the facility and its operations. Those who were unable to tour asked custody staff about the jail's general size, age, operations, as well as how specific areas of the jail are used, such as restrictive housing.

4. Task Force Survey Results & Trajectory

- Chair Senator Saldaña facilitated a discussion on members' initial impressions of proposed recommendations.
- Based on survey responses and commentary, most members are supportive of
 establishing statewide standards and oversight, several members have concerns
 about funding for localities to meet the standards and questions about who
 would be establishing and enforcing the standards, and several members have
 not yet expressed their views.
- Some members expressed interest in additional data on those in jails and the services provided and others expressed that the Task Force should act quickly to improve jail conditions within the window available now, especially given that most members are support of statewide authority.
- Members expressed interest in potentially recommending the creation of more regional facilities, establishing a Commission to set standards and have the authority to meaningfully enforce them, and launching a central clearinghouse for jail data.


The Frequency of Each Service

- Medication Management Primary




