ERPP waxay u baahan tahay mulkiilayaasha inay isku dayaan inay heshiis la galaan kireeystayaasha oo ku saabsan kirada aan la bixin ka hor intaanay weydiisan guri ka saarista maxkamadda. Waxaad xaq u yeelan kartaa **kaalmada kirada** iyo **kaalmada sharciga ayadoo loo marayo ERPP**.

Haddii aad kaqaybqaadato ERPP, mulkiilahaagu waa inuu kula shaqeeyaa adiga iyo takhasusle katirsan xaafadaada **Dispute Resolution Center (DRC, Xarunta Xalinta Khilaafaadka)**.
