1 **II. STIPULATION**

2 The parties to this stipulation, Plaintiff STATE OF WASHINGTON (STATE) and
3 Defendant GOOGLE, LLC (GOOGLE), desiring to resolve all claims arising out of the State's
4 First Amended Complaint for Civil Penalties and for Injunctive Relief for Violations of
5 RCW 42.17A, hereby enter into the following stipulation:

6 1. Defendant GOOGLE agrees to pay to the STATE \$400,000.00 for failing to
7 provide timely books of account as requested pursuant to RCW 42.17A.345 and
8 WAC 390-18-050 during the period from June 4, 2018, until the date of this stipulation.
9 GOOGLE does so without conceding the enforceability or applicability of the statute and
10 regulation.

11 2. Defendant GOOGLE agrees to pay the STATE \$23,659.76 for its reasonable
12 attorneys' fees and costs incurred in this case and for its costs of investigation.

13 3. Defendant GOOGLE agrees to pay these amounts by wire transfer, pursuant to
14 instructions that will be provided by the STATE, or by check or money order made payable to
15 the Washington State Treasurer and sent to the **Public Disclosure Commission, PO Box 40908,**
16 **Olympia, WA 98504-0908** within 30 days from the date of the entry of this Judgment. Payment
17 should reference/identify the case number and respondent's name for reference.
