Ferguson, Attorney General of Washington, in the name and by the 15 authority of the State of Washington, pursuant to RCW 43.10.232 and at the request of 16 17 Mark Lindquist, Pierce County Prosecuting Attorney, hereby allege that RYAN JAMES LEWIS did commit the following crimes: 18 19 COUNT I - DEFRAUDING A PUBLIC UTILITY IN THE FIRST DEGREE On or about January 2, 2016, in the State of Washington, Pierce County, 20 21

On or about January 2, 2016, in the State of Washington, Pierce County, RYAN JAMES LEWIS, did make, or cause to be made, a connection or reconnection with property owned or used by the utility to provide utility service without the authorization or consent of the utility; and/or did use or receive the direct benefit of all or a portion of the utility service with knowledge of, or reason to believe that, the diversion, or unauthorized connection existed at the time of the use or that the use or receipt was without the authorization or consent of the utility, in furtherance of criminal activity; contrary to RCW 9A.61.020,

RCW 9A.61.030, and RCW 9A.08.030(2)(b), and against the peace and dignity of the State of Washington. (Class B Felony with a maximum penalty of ten (10) years in prison and/or a \$20,000 fine pursuant to RCW 9A.20.021(1)(b), plus restitution and assessments.)

COUNT II - DEFRAUDING A PUBLIC UTILITY IN THE FIRST DEGREE

On or about September 24, 2013, in the State of Washington, Pierce County, RYAN JAMES LEWIS, did use or receive the direct benefit of all or a portion of the utility service with knowledge of, or reason to believe that, the diversion, or unauthorized connection existed at the time of the use or that the use or receipt was without the authorization or consent of the utility, in furtherance of criminal activity; contrary to RCW 9A.61.020, RCW 9A.61.030, and RCW 9A.08.030(2)(b), and against the peace and dignity of the State of Washington. (Class B Felony with a maximum penalty of ten (10) years in prison and/or a \$20,000 fine pursuant to RCW 9A.20.021(1)(b), plus restitution and assessments.)

COUNT III - VIOLATION OF THE WATER POLLUTION CONTROL ACT

On or about January 29, 2015, in the State of Washington, Pierce County, RYAN JAMES LEWIS, did throw, drain, run, or otherwise discharge, or did cause, permit, or allow to be thrown, run, drained, allowed to seep or otherwise discharged, into the waters of this state organic or inorganic matter that causes or tends to cause pollution of such waters; to wit: acid, contrary to RCW 90.48.080 and contrary to RCW 90.48.140. (Gross misdemeanor with a maximum penalty of 364 days imprisonment or \$10,000 fine, or both pursuant to RCW 90.48.140, plus restitution, assessments and court costs.)

	On or about May 12, 2015, in the State of Washington, Pierce County,

3	RYAN JAMES LEWIS, did knowingly transport, store, handle, or dispose of a hazardous
4	substance, to wit: acid exhibiting characteristics of ignitability and/or corrosivity as stated in
5	WAC 173-303-090, in violation of Ch. 70.105 RCW, to wit: implementing regulations
6.	WAC 173-303-145(3); contrary to RCW 70.105.085(1)(b) and 70.105.010. (Gross
7	misdemeanor with a maximum penalty of 364 days imprisonment and/or a \$10,000 fine,
8	pursuant to RCW 70.105.090, plus restitution, assessments and court costs.)
9	COUNT V – RECKLESS ENDANGERMENT
10	On or about May 8, 2015, in the State of Washington, Pierce County,
11	RYAN JAMES LEWIS, did recklessly engage in conduct which did create a substantial risk of
12	death or serious physical injury to another person, to wit: Daniel Wayne, contrary to
13	RCW 9A.36.050(1). (Maximum Penalty 364 days in jail or \$5,000 fine, or both, pursuant to
14	RCW 9A.36.050(2) and RCW 9A.20.021(2), plus restitution, assessments and court costs.)
