JUDGMENT

THIS MATTER came on regularly before the undersigned judge of the above-entitled Court. Plaintiff, STATE OF WASHINGTON (STATE), appearing through its attorneys of record, ROBERT W. FERGUSON, Attorney General, LINDA A. DALTON, Senior Assistant Attorney General and S. TODD SIPE, Assistant Attorney General, and Defendant, EVERGREEN FREEDOM FOUNDATION d/b/a FREEDOM FOUNDATION, appearing through its attorney, MARK LAMB, The North Creek Law Firm, having reached an agreement as to the civil penalty, costs, and reasonable attorney fees in this matter, and having apprised the Court of their agreement to the entry of this judgment for the purpose of settling and compromising this action brought under RCW 42.17A. The Court, having reviewed the records and files herein, and having found the settlement to be a just and proper resolution of this matter, and being otherwise fully advised in the premises, it is hereby **ORDERED** as follows:

1. Defendant EVERGREEN FREEDOM FOUNDATION d/b/a FREEDOM FOUNDATION is hereby assessed a civil penalty, under the provisions of RCW 42.17A, in the amount of \$4,330 payable to the State of Washington.


2. Defendant EVERGREEN FREEDOM FOUNDATION d/b/a FREEDOM FOUNDATION shall pay to the State of Washington the amount of \$2,368 as reasonable attorney fees and \$1,962 in court costs and costs of investigation as authorized under RCW 42.17A.765.

1 3. Defendant EVERGREEN FREEDOM FOUNDATION d/b/a FREEDOM
2 FOUNDATION shall pay the State the civil penalty (\$4,330) and fees and costs (\$4,330)
3 within 30 days of the entry of the Judgment.
