7 **STIPULATION**


8 The parties to this stipulation, Plaintiff, STATE OF WASHINGTON (STATE) and
9 Defendant, JIM CASTROLANG, individually, and in his capacity as Executive Director and
10 Chair of the SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, desiring to
11 resolve claims arising out of the State's Complaint against Mr. CastroLang, hereby enter into the
12 following stipulation:


- 13 1. Defendant JIM CASTROLANG, individually, and in his capacity as Executive Director and
14 Chair of the SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, agrees to
15 pay an assessed civil penalty in the amount of \$1,500 for violations of RCW 42.17A as
16 alleged in the State's Complaint including failing to timely disclose contributions received
17 and expenditures made, failing to timely update political committee registration forms, and
18 failing to timely deposit contributions received by Defendant SPOKANE COUNTY
19 DEMOCRATIC CENTRAL COMMITTEE.
- 20 2. The parties to this stipulation acknowledge that Defendant JIM CASTROLANG,
21 individually, and in his capacity as Executive Director and Chair of the SPOKANE
22 COUNTY DEMOCRATIC CENTRAL COMMITTEE did not intend to violate any laws.
- 23 3. Defendant JIM CASTROLANG, individually, and in his capacity as Executive Director and
24 Chair of the SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, further
25 agrees to pay the State the civil penalty (\$1,500) in three equal installments of \$500, payable
26 on February 28, 2019, August 31, 2019, and February 28, 2020.

14 THIS MATTER came on regularly before the undersigned judge of the above-entitled
15 Court. Plaintiff, STATE OF WASHINGTON, appearing through its attorneys of record,
16 ROBERT W. FERGUSON, Attorney General, LINDA A. DALTON, Senior Assistant Attorney
17 General, and S. TODD SIPE, Assistant Attorney General, and Defendant JIM CASTROLANG,
18 individually, and in his capacity as Executive Director and Chair of the SPOKANE COUNTY
19 DEMOCRATIC CENTRAL COMMITTEE, appearing through his attorney of record, JAMES
20 B. KING, apprised the Court of their agreement to the entry of this judgment for the purpose of
21 settling and compromising this action brought under RCW 42.17A. The Court, having reviewed
22 the records and files herein, and having found the settlement to be a just and proper resolution
23 of this matter, and being otherwise fully advised in the premises, hereby ORDERS as follows:

- 24 1. Defendant JIM CASTROLANG, individually, and in his capacity as Executive Director and
25 Chair of the SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, is hereby
26 assessed a civil penalty, for violations of the provisions of RCW 42.17A as alleged in the
State's Complaint and outlined in the Stipulation, in the amount of \$1,500 payable to the
State of Washington.
2. Defendant JIM CASTROLANG, individually, and in his capacity as Executive Director and
Chair of the SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, shall pay


1 the State the civil penalty (\$1,500) in three equal installments of \$500, payable on February


