The parties understand and agree that if the conditions of that plea agreement are not met, including the payment of restitution pursuant to the agreement, the State reserves the right to refile these criminal charges in the above-entitled cause number and the Defendant does not waive any objections or defenses to such charges.

The Attorney General for the State of Washington agrees not to charge Sam A. Adams, or his marital community, with any additional crimes arising out of this investigation. In

addition, Mr. and Mrs. Sam A. Adams agree not to file any legal action against the State of Washington Attorney General's Office, the Department of Revenue ("DOR"), the Employment Security Division or any of their employees for any matters arising from this investigation and prosecution. This provision, however, does not preclude Mr. or Mrs. Adams from seeking any relief from claimed retail sales tax liability or obtaining a refund of sale taxes previously paid to DOR.
