Muxuu yahay Eviction Resolution Program (ERPP)?

Maxkamadda Sare ee degmadaadu waxay isticmaashaa barnaamijkaan. ERPP waxay u baahan tahay mulkiilayaasha inay isku dayaan inay heshiis la galaan kireystayaasha oo ku saabsan kirada aan la bixin ka hor intaanay weydiisan guri ka saarista maxkamadda. Waxaad xaq u yeelan kartaa kaalmada kirada iyo kaalmada sharciga ayadoo loo marayo ERPP.

Haddii aad kaqaybqaadato ERPP, mulkiilahaagu waa inuu kula shaqeeyaa adiga iyo takhasusle katirsan xaafadaada **Dispute Resolution Center (DRC, Xarunta Xalinta Khilaafaadka)**. Haddii ay taasi dhibaatada xalineyso, waa si wanaagsan! Haddii aanan dhibaatada la xalin karin, DRC ayaa kusiin doonta dhex dhexaadin bilaasha. Dhex-dhexaadintu waa ikhtiyaar – kaliya waxey dhacdaa haddi ay labada dhinac isku raacaan in ay sidaa sameeyaan.
