3 STIPULATION

4 The parties to this stipulation, Plaintiff, STATE OF WASHINGTON, and the  
5 Defendant, WASHINGTON STATE ASSOCIATION FOR JUSTICE, being desirous of  
6 resolving all claims arising out of the State's complaint, hereby enter into the following  
7 stipulation:


8 1. Defendant WASHINGTON STATE ASSOCIATION FOR JUSTICE agrees to pay the  
9 STATE OF WASHINGTON an assessed civil penalty in the amount of \$1,500 for its  
10 violations of RCW 42.17A for failing to properly file three (3) Lobbyist Employer annual  
11 and contribution reports for the year 2012, this amount to be paid within 30 days of the date  
12 of entry of the Judgment.

13 2. Defendant WASHINGTON STATE ASSOCIATION FOR JUSTICE agrees to pay the  
14 STATE OF WASHINGTON, in a separate transmittal, the total amount of \$7,740.00 as  
15 attorney fees, court costs, and costs of investigation in this action, this amount to be paid  
16 within 30 days of the date of entry of the Judgment.

2 THIS MATTER came on regularly before the undersigned judge of the above-entitled  
3 Court. The Plaintiff, STATE OF WASHINGTON, appearing through its attorneys of record,  
4 ROBERT W. FERGUSON, Attorney General, LINDA A. DALTON, Senior Assistant  
5 Attorney General, and CHAD C. STANDIFER, Assistant Attorney General, and the  
6 Defendant, WASHINGTON STATE ASSOCIATION FOR JUSTICE, appearing through its  
7 attorney, DMITRI L. IGLITZIN, apprised the Court of their agreement to the entry of this  
8 judgment for the purpose of settling and compromising this action brought under RCW  
9 42.17A. The Court, having reviewed the records and files herein, and having found the  
10 settlement to be a just and proper resolution of this matter, and being otherwise fully advised in  
11 the premises, now, therefore, it is hereby

12 ORDERED that Defendant, WASHINGTON STATE ASSOCIATION FOR JUSTICE,  
13 is assessed a civil penalty, under the provisions of RCW 42.17A, in the amount of \$1,500.00  
14 payable to the State of Washington. It is further

15 ORDERED that Defendant WASHINGTON STATE ASSOCIATION FOR JUSTICE  
16 shall pay to the STATE OF WASHINGTON by separate transmittal, the amount of \$5,240 as  
17 attorney fees and court costs as authorized under RCW 42.17A.765. It is further


