

12 THIS MATTER having come before the undersigned Judge of Thurston County
13 Superior Court upon Motion for Entry of Default Judgment by Plaintiff, State of Washington
14 Public Disclosure Commission, by and through its Attorney General, ROB MCKENNA, and
15 Assistant Attorney General, H. BRUCE MARVIN, and an ORDER OF DEFAULT having
16 been entered in this matter on April 29, 2005, and Respondent, ALFRED J. KIEFER, JR.,
17 having been properly served and provided notice of all proceedings and having not appeared,
18 and the court having considered the records and files herein, NOW, THEREFORE, it is
19 HEREBY ORDERED, ADJUDGED AND DECREED that Defendant KIEFER, shall be, and
20 hereby is assessed a civil penalty, pursuant RCW 42.17.390(3), in the amount of \$5,000;
21 Plaintiff's reasonable attorney's fees, legal costs, investigative costs, and post judgment
22 interest as set forth above.

23 IT IS FURTHER ORDERED that Defendant Kiefer shall complete and file a Statement
24 of Financial Affairs (Form F-1) with the Public Disclosure Commission for the year 2003 as
25 required under RCW 42.17.240 within 30 days of the entry of this Judgment and this Court

1 shall retain jurisdiction over this matter until such time as Defendant Kiefer has complied with
2 this requirement.




