3           Plaintiff, State of Washington, having commenced this action on October 5, 2007 pursuant

4           to the Unfair Business Practices—Consumer Protection Act (“Consumer Protection Act”),

5           Chapter 19.86 RCW; and

6           Defendants Eireen Ejem-Dagohoy, Wilmyr Dagohoy and Cheapest-Magz (together,

7           “Defendants”), having been served with a Summons and Complaint; and

8           Plaintiff appearing by and through its attorneys, Robert M. McKenna, Attorney General;

9           and Paula Selis, Senior Council and Defendants appearing through their attorney Christopher Rao;

10           and

11           Plaintiff and Defendants having agreed on a basis for the settlement of the matters alleged

12           in the Complaint, and to the entry of this Consent Decree against Defendants without the need for

13           trial or adjudication of any issue of law or fact; and

14           Plaintiff and Defendants having agreed that this Consent Decree does not constitute

15           evidence or an admission regarding the existence or non-existence of any issue, fact, or violation

16           of any law alleged by Plaintiff; and

17           Defendants recognize and state that this Consent Decree is entered into voluntarily and

18           that no promises or threats have been made by the Attorney General’s Office or any member,

19           officer, agent or representative thereof to induce them to enter into this Consent Decree, except as

20           provided herein; and

21           Defendants waive any right they may have to appeal from this Consent Decree; and

22           Defendants further agree that they will not oppose the entry of this Consent Decree on the

23           grounds the Consent Decree fails to comply with Rule 65(d) of the Rules of Civil Procedure, and

24           hereby waive any objections based thereon; and

1      Defendants further agree that this Court shall retain jurisdiction of this action for the  
2 purpose of implementing and enforcing the terms and conditions of the Consent Decree and for all  
3 other purposes; and

4      The Court finding no just reason for delay;

5      NOW, THEREFORE, it is hereby ORDERED, ADJUDGED, AND DECREED as  
6 follows:

7                   **II. GENERAL**

8      2.1. Jurisdiction. This Court has jurisdiction of the subject matter of this action and of  
9 the parties. Plaintiff's Complaint in this matter states claims upon which relief may be granted  
10 under the provisions of the Consumer Protection Act, Chapter 19.86 RCW.

11     2.2. Defendants. For purposes of this Consent Decree, the term "Defendants" where  
12 not otherwise specified shall mean Eireen Ejem-Dagohoy, individually and on behalf of her  
13 marital community, and Wilmyr Dagohoy, individually and on behalf of his marital  
14 community, and both Eireen Dagohoy and Wilmyr Dagohoy doing business as Cheapest-  
15 Magz.

16                   **III. INJUNCTIONS**

17     3.1. Application of Injunctions. The injunctive provisions of this Consent Decree shall  
18 apply to Defendants, and Defendants' successors, assigns, officers, agents, servants, employees,  
19 representatives, and all other persons or entities in active concert or participation with Defendants.

20     3.2. Notice. Defendants shall immediately inform all successors, assigns, transferees,  
21 officers, agents, servants, employees, representatives, attorneys, and all other persons or entities in  
22 active concert or participation with Defendants in the Complaint of the terms and conditions of  
23 this Consent Decree.

24     3.3. Injunctions. Defendants and all successors, assigns, transferees, officers, agents,  
25 servants, employees, representatives, attorneys, and all other persons or entities in active concert  
26 or participation with Defendants are hereby permanently enjoined and restrained from directly or

1 indirectly advertising, selling, auctioning or marketing magazine subscriptions to Washington  
2 residents or from a location in Washington.

3       3.4 Defendants and all successors, assigns, transferees, officers, agents, servants,  
4 employees, representatives, attorneys, and all other persons or entities in active concert or  
5 participation with Defendants are hereby permanently enjoined and restrained from failing to  
6 deliver any products or services which they have represented will be delivered to consumers.

7       3.5 Defendants and all successors, assigns, transferees, officers, agents, servants,  
8 employees, representatives, attorneys, and all other persons or entities in active concert or  
9 participation with Defendants are hereby permanently enjoined and restrained from violating any  
10 provisions of the Unfair-Business Practices—Consumer Protection Act, RCW 19.86.

#### 11                  IV. RESTITUTION

12       4.1. Pursuant to RCW 19.86.080, within forty (40) days of the entry of the Consent  
13 Decree, Defendants shall mail checks in the amount of the consumers' subscription payment to  
14 the consumers listed on Exhibit A for whom proof of receipt of the subscription has not been  
15 made pursuant to Paragraph 4.1. The mailing containing the check shall include a letter with  
16 the following text:

18       "Dear Consumer:

19       In 2006 or 2007 you ordered a magazine subscription through our company,  
20 Cheapest-Magz, on the eBay auction site. Our records indicate that the  
21 subscription was not delivered to you. Pursuant to a settlement agreement  
22 reached between Cheapest-Magz and the Washington State Attorney General's  
23 Office, you are eligible to receive a refund for the magazine subscription you  
24 paid for. Enclosed you will find a check for the amount you paid for the  
subscription. If you have any questions about the State of Washington's case  
against Cheapest-Magz or your refund, please call the Washington State  
Attorney General's Office's Consumerline toll-free at 1-800-692-5082 or  
locally at 206-464-6811. You may also visit the Web site for the Washington  
State Attorney General's Office at [www.atg.wa.gov](http://www.atg.wa.gov).

1           4.2 Defendants shall immediately place in trust with their attorney the amount of  
2 \$3,596.00 to cover the potential cost of restitution.

3

4           **V. CIVIL PENALTIES**

5           5.1. Pursuant to RCW 19.86.140, Plaintiff shall have and recover and Defendants shall  
6 be liable for and shall pay civil penalties in the amount of \$6,000.00, provided that \$1,404.00 is  
7 payable, and \$4,596.00 of such civil penalties are suspended on condition of compliance with  
8 Section III of the terms of this Decree.

9

10          **V. ATTORNEY COSTS AND FEES**

11          11.1. Pursuant to RCW 19.86.080, Plaintiff shall recover and Defendants shall pay the  
12 costs and reasonable attorneys' fees incurred by the Plaintiff in pursuing this matter in the amount  
13 of \$10,000.00.

14          12.2. Payment owing under this provision shall be in the form of a valid check paid to  
15 the order of the "Attorney General—State of Washington." Payment shall be sent to the Office  
16 of the Attorney General, Attention: Cynthia Lockridge, Administrative Office Manager, 800  
17 Fifth Avenue, Suite 2000, Seattle, Washington, 98104-3188.

19          **VI. ENFORCEMENT**

20          21.1. Violation of any of the terms contained in Section III of this Consent Decree shall  
21 subject Defendants to a civil penalty of up to \$25,000.00 per violation pursuant to RCW  
22 19.86.140.

23          22.2. In any action to enforce the terms of this Decree, Plaintiff may seek additional  
24 remedies, including, but not limited to, restitution, injunctive relief, and reasonable attorneys' fees  
25 and costs, in addition to any other remedies permitted by law.

26          23.3. This Consent Decree is entered pursuant to RCW 19.86.080. Jurisdiction is  
retained for the purpose of enabling any party to this Consent Decree with or without the prior

1 consent of the other party to apply to the Court at any time for enforcement of compliance with  
2 this Consent Decree, to punish violations thereof, or to modify or clarify this Consent Decree.

3       7.4. Representatives of the Office of the Attorney General shall be permitted to access,  
4 inspect and/or copy all business records or documents under control of Defendants in order to  
5 monitor compliance with this Consent Decree within fourteen (14) days of written request to  
6 Defendants, provided that the inspection and copying shall be done in such a way as to avoid  
7 disruption of Defendants' business activities. Failure to comply with this section will be  
8 considered a violation of the terms of this Consent Decree.

9       7.5. Representatives of the Office of the Attorney General may be permitted to  
10 question Defendants, or any officer, director, agent, or employee of any business organization  
11 affiliated with Defendants, in the form of a deposition, pursuant to the provisions and notice  
12 requirements of CR 30, and to issue interrogatories and requests for production of documents,  
13 pursuant to the provisions and notice requirements of CR 33 and CR 34, in order to monitor  
14 compliance with this Consent Decree.

15       7.6. Nothing in this Consent Decree shall be construed as to limit or bar any other  
16 governmental entity or consumer from pursuing other available remedies against Defendants.

17       7.7. Under no circumstances shall this Consent Decree or the name of the State of  
18 Washington, the Office of the Attorney General, Consumer Protection Division, or any of their  
19 employees or representatives be used by Defendants in connection with any selling, advertising,  
20 or promotion of products or services, or as an endorsement or approval of Defendants' acts,  
21 practices or conduct of business.

22       7.8      This Consent Decree resolves all issues raised by the Attorney General under the  
23 Consumer Protection Act pertaining to the acts or omissions addressed in the Complaint filed in  
24 this matter.

## VII. TERMS OF PAYMENT

8.1 The judgment amount of \$15,000.00 is to be paid in full by August 10, 2008 and shall be paid as follows:

a. Within forty (40) days of the signing of this Consent Decree, \$3596.00 shall be distributed by Defendants as restitution to the consumers listed in Exhibit A.

b. By no later than May 10, 2008, Defendants shall make a payment of \$5,404.00 which shall be applied to attorney costs and fees.

c. By no later than June 10, 2008, Defendants shall make a payment of \$2,000.00 which shall be applied to attorney costs and fees.

d. By no later than July 10, 2008, Defendants shall make a payment of \$2,000.00 which shall be applied to attorney costs and fees.

e. By no later than August 10, 2008, Defendants shall make a payment of \$2,000.00 which shall be applied to attorney costs and fees and civil penalties.

## **IX. DISMISSAL AND WAIVER OF CLAIMS**

9.1 Upon entry of this Consent Decree, all claims in this matter not otherwise addressed by this Consent Decree are dismissed.




