INFORMATION

I, Robert W. Ferguson, Attorney General of Washington, in the name and by the authority of the State of Washington, pursuant to RCW 43.10.232 and at the request of Daniel Satterberg, King County Prosecuting Attorney, hereby allege THOMAS WISE did commit the following crimes:

**COUNT I**

**DEFRAUDING A PUBLIC UTILITY IN THE FIRST DEGREE**

On or between January 1, 2013 and May 1, 2014, in the State of Washington, King County, the above-named Defendant, did make, or cause to be made, a connection or reconnection with property owned or used by the utility to provide utility service without the authorization or consent of the utility; and/or tamper with property owned or used by the utility to provide utility services in furtherance of criminal activity, to wit: unlawful dumping of solid waste without a permit; contrary to RCW 9A.61.020 and RCW 9A.61.030, and against the peace and dignity of the State of Washington. (Gross misdemeanor with a maximum penalty of ten (10) years in prison and/or a \$20,000 fine pursuant to RCW 9A.20.021(1)(b), plus restitution and assessments.)

1 **COUNT II**

2 UNLAWFUL DUMPING OF SOLID WASTE WITHOUT A PERMIT

3 On or between January 1, 2013 and May 1, 2014, in the State of Washington, King  
4 County, the above-named Defendant, did dump or deposit solid waste onto or under the surface  
5 of the ground, in an amount of one cubic yard or more; contrary to RCW 70.95.030, and  
6 RCW 70.95.240, and against the peace and dignity of the State of Washington.

7 (Gross misdemeanor with a maximum penalty of three hundred sixty-four (364) days jail and/or a \$5,000 fine  
8 pursuant to RCW 9A.20.021(2) and RCW 70.95.240(c), plus restitution and assessments.)

9 **COUNT III**

10 MAKING A FALSE OR MISLEADING STATEMENT TO A PUBLIC SERVANT

11 On or about February 17, 2014, in the State of Washington, King County, the above-  
12 named Defendant, did knowingly make a false or misleading material statement to a public  
13 servant; contrary to RCW 9A.76.175, and against the peace and dignity of the State of  
14 Washington.

15 (Gross misdemeanor with a maximum penalty of three hundred sixty-four (364) days jail and/or a \$5,000 fine  
16 pursuant to RCW 9A.20.021(2), plus restitution and assessments.)
