Department I of the Court, composed of Chief Justice González and Justices Johnson,
Owens, Gordon McCloud and Montoya-Lewis, considered at its July 11, 2023, Motion Calendar
whether to waive the filing fee for five personal restraint petitions filed by Allah Allah during
May 2023. Department I also considered the Supreme Court Clerk's request to declare Allah
Allah a vexatious litigant and impose limits on his ability to initiate cases at the Court of Appeals
and the Supreme Court based on his lengthy history of duplicative and frivolous court filings.
This includes nearly 100 appellate court cases, most based on the same legal argument about his
legal name and dismissed as frivolous. His history also includes attempts to initiate dozens of
additional cases in the Supreme Court by filing documents that are not provided for by the Rules
of Appellate Procedure, such as motions for temporary restraining orders, complaints, motions to
vacate judgements, affidavits of complaint, UCC financing statements, demands, petitions to
correct dispositions, petitions to produce disclosure, mandatory requests, motions for order to
terminate debtor, summons, peremptory writs, and affidavits of prejudice. These filings

IT IS ORDERED:

That the Petitioner's motions to waive filing fees for the five personal restraint petitions filed during May 2023 are all denied. The Clerk's motion to declare Petitioner a vexatious litigant is granted and the following limits are hereby placed on Allah Allah's ability to file in the appellate courts:

- (1) Any document Allah Allah files that is not provided for by the Rules of Appellate Procedure will not be filed or acknowledged;
- (2) Any document Allah Allah files attempting to initiate a case based on a legal argument related in any way to his name or personal identifiers will not be filed or acknowledged;
- (3) Allah Allah is permitted to initiate new cases only if the issues he seeks to raise facially merit determination by a court and are not repetitive of previous cases Allah Allah has filed or attempted to file;
- (4) Allah Allah is prohibited from filing any cases with the Court of Appeals. All cases must be initiated at the Supreme Court for review by the Supreme Court Clerk for compliance with the above-detailed filing restrictions; and
- (5) The Supreme Court Clerk's decisions regarding the compliance of Allah Allah's filings will not be subject to a motion to modify.
