4 and bring it with you to your first court appearance.


5 You shall present yourself, with this Summons, to the Franklin County Correction

INFORMATION

I, ROBERT W. FERGUSON, Attorney General of Washington, in the name and by the authority of the State of Washington, pursuant to RCW 43.10.232 and after a written request from the Franklin County Prosecuting Attorney, do accuse JUSTIN THOMAS HUSOM as follows:

COUNT I

I, ROBERT W. FERGSUON, Attorney General of Washington, do accuse JUSTIN THOMAS HUSOM of the crime of CUSTODIAL SEXUAL MISCONDUCT IN THE FIRST DEGREE, committed as follows:

That the defendant JUSTIN THOMAS HUSOM, in the State of Washington, during the period of time from December 23, 2011, through May 11, 2012, did have sexual intercourse with P.S.M., who was a resident of an adult county or state correctional facility or who was under correctional supervision while the defendant was an employee or contract

1 personnel of the correctional agency and the defendant had, or P.S.M. reasonably believed he
2 had, the ability to influence the terms, conditions, length, or fact of incarceration or
3 correctional supervision, contrary to RCW 9A.44.160(1)(a), and against the peace and dignity
4 of the State of Washington.

5 Custodial sexual misconduct in the first degree is a class C felony. RCW
6 9A.44.160(3). The maximum punishment is five (5) years imprisonment and a \$10,000 fine.
7 RCW 9A.20.021(1)(c).

8 **COUNT II**

9 And I, ROBERT W. FERGUSON, Attorney General of Washington, do accuse
10 JUSTIN THOMAS HUSOM of the crime of CUSTODIAL SEXUAL MISCONDUCT IN
11 THE FIRST DEGREE, a crime of the same or similar character, and/or a crime based on the
12 same conduct or on a series of acts connected together or constituting parts of a single scheme
13 or plan, and/or so closely connected in time, place and occasion that it would be difficult to
14 separate proof of one charge from proof of the others, committed as follows:

15 That the defendant JUSTIN THOMAS HUSOM, in the State of Washington, on or
16 about the 2nd day of February, 2014, did have sexual intercourse with K.V., a resident of an
17 adult county or state correctional facility or who was under correctional supervision while the
18 defendant was an employee or contract personnel of the correctional agency and the defendant
19 had, or K.V. reasonably believed he had, the ability to influence the terms, conditions, length,
20 or fact of incarceration or correctional supervision, contrary to RCW 9A.44.170(1), and
21 against the peace and dignity of the State of Washington.
